Illinois Medicaid

Effective with Dates of Service July 1, 2012 and after - 6 month timely filing instead of 1 year.

Review the handbook for the numerous changes as a result of the 2012 laws.

5010 UPDATE

CMS extension ended 6/30/12

Most payers have now converted to the 5010 format.

Availity and other clearinghouse's are still up-converting your 4010 files, however there still could be issues with this, it is no guarantee.

Version 17 is the ANSI 5010 Compliant program needed for compliance for 5010 submission for most clearinghouses.

This version provides the numerous missing fields that may be required to generate a 5010 compliant claim.

SERVICE PACK 3.3 FOR VERSION 17!

Version 17 Service Pack 3 was released on 4/25/12, there was an issue with Office Hours so it was pulled back for further testing. McKesson has now released SP3.3.

NOTE: Repeating Breaks and Appointments are now handled differently with this service pack.

If you use the repeat feature, documentation needs to be read before you install and upgrade.
