Are you ready for the transition to NGS from WPS?

This is happening on Saturday September 7th, all claims submitted on or after this date need to be submitted to the new Medicare contractor NGS not WPS.

The New CMS 1500 Claim Form

The National Uniform Claim Committee (NUCC) has approved a transition timeline for 1500 Claim Form (version 02/12).

The approved transition timeline is as follows:

- January 6, 2014: Payers begin receiving and processing paper claims submitted on the revised 1500 Claim Form (version 02/12)
- January 6 through March 31, 2014: Dual use period during which payers continue to receive and process paper claims submitted on the old 1500 Claim Form (version 08/05)
- April 1, 2014: Payers receive and process paper claims submitted only on the revised 1500 Claim Form (version 02/12)

This will be accommodated only in Version 19 Medisoft software.

AVAILITY CHANGES COMING IN 2014!

Availity will no longer support the free exchange of certain transactions delivered via EDI connections to their network. The change affects all transactions submitted via batch electronic data interchange (EDI) and in real-time.

Please note that the Availity Web portal—and the payers supported on the portal—will not change. The Availity Web portal continues to be offered at no cost to providers.

Financial pressures on private plans, coupled with ever-expanding government mandates that create new demands under health care reform, have necessitated this change to our business model.

Pricing will be per month per provider organization (includes Claims, ERA's & Eligibility) based on the number of claims being submitted.
